

# **Cookie Policy**

Quant AB, Company Reg. No. 556975-5654, St. Göransgatan 66, 112 33 Stockholm, Sweden ("Quant" or "we") use cookies to improve your experience when using our website, to generate statistics and analyze users, as well as to enhance our security.

#### What is a cookie?

A cookie is a small text file that is saved either temporarily or for a set period of time on your device (computer, tablet, smart phone etcetera). Cookies may be used to e.g. show relevant and personalized advertisements, remember user settings or allow visitors to navigate the website.

There are two main types of cookies;

- permanent cookies which are stored on your device for a specified period of time,
   and
- 2) **session cookies** which are stored on your device while you are using the website and deleted when you close your browser.

#### Types of cookies we use

We use the following types of cookies:

- Strictly necessary cookies (e.g. allow you to navigate on our website and use its features).
- Third-party cookies (e.g. Google Analytics) → With our permission, third party cookies are placed on our
  website by third parties such as advertising networks. These are mainly used to show you relevant and
  personalized advertisements, or to measure the effectiveness of an advertising campaign, to record traffic
  flow, ad clicks, etcetera.

Below you see the complete list of cookies used, and for how long each cookie is saved on your device.
